Our magazine will publish original articles of proven scientific quality. We will strictly ensure that there are no bad practices in scientific publication, such as the deformation or invention of data, plagiarism or duplication. The authors have the responsibility to guarantee that their work is original and unpublished, the result of the consensus of all the authors, who comply with the current legislation and have the necessary permits, in case they are necessary. Articles that do not keep these ethical standards will be discarded. The opinions and facts consigned in each article are the exclusive responsibility of their authors.

In any case, taking as reference the main international recommendations and, especially, those of the Committee on Publication Ethics (COPE) we will try to guarantee at all times that the behaviors are appropriate, as well as reject the bad practices that may occur.

Privacy Statement. The names, e-mail addresses, or any other personal information provided by the authors will only be used for the purposes of the Archive and Publications Service and will not be available for any other purpose.

RULES FOR THE DELIVERY AND PRESENTATION OF ORIGINALS

1.- The works presented, according to the objectives of the magazine, should contribute to the knowledge and dissemination of unpublished research on various historical, artistic, literary, cultural aspects of Seville, its province and by extension its ancient Kingdom, without chronological limit.

2.- Any work must be accompanied with a sheet that shows: title of the same, name and surname of the author or authors, address, telephone, population and email, as well as their academic and professional situation and the name of the scientific institution to whose it belongs.

3.- The works must be unpublished. Returned jobs will not be accepted again. The original, made with any of the usual word processors, will be presented at the Servicio de Archivo y Publicaciones de la Diputación de Sevilla, avda. Menéndez Pelayo, 32. It can also be submitted by mail: archivo@dipusevilla.es

4.- The extension will be between 15 and 30 pages, DIN-A4 format, recorded notes, graphs, tables and bibliography, with font Times New Roman, 12 points and 1.5 line spacing. The original will be accompanied by a brief summary of the work in Spanish and English, which should not exceed 150 words, and the corresponding keywords, also in Spanish and English.



5.- An excessive number of textual quotations will be avoided. The transcripts or literal reproductions, both literary and documentary, will go in Roman print and in quotation marks. If they are extensive (more than three lines) they will go in a paragraph with indentation and one point less in size. On the other hand, the contribution of the author in this type of quotations should be enclosed in brackets to distinguish them clearly from the cited text.

The cursive letter will be used in titles of works, books, magazines and newspapers, as well as for words in another language. Regarding the use of capital letters, will adjust to the standards of the RAE (Real Academia de la Lengua Española).

6.- The graphic material to illustrate the text, when necessary, must be original, presented numbered and with a short foot or legend. It will be hand over in files apart from the text. In the case of photographs, they will be presented in JPG or TIFF format with a resolution of 300 pp to your print size. As a general rule, illustrations may not exceed twelve. All graphic material must be original from the author or have the relevant reproduction authorizations.

7.- The notes, numbered consecutively, will be written at the bottom of the page, with font Times New Roman, 10 points.

8.- Bibliographic references, respecting order, punctuation and spelling will adjust to the following criteria, following as far as possible for their drafting the UNE 50-104-94 and ISO 690 and 690-2 standards:

a) From monographs:

Author: Surname (upper case) and name

Title: in italics

Tomo or volume, if any: t. ; vol.

Publication (place, editor)

Year

Reference to the page or pages: p. / pp.

Example: AGUILAR PIÑAL, Francisco: *Historia de Sevilla: siglo XVIII*. Sevilla: Universidad, 1989, p. 116.

b) Contributions, introductions or prefaces in monographs and articles in serial publications:

Author: in the same way as in the monographs

Title: in quotation marks, in round letters and without underlining

Title of the monograph or magazine where it is inserted: in italics

Year, volume, number (in the case of serial publications)

Publication (place, editor) and year (in the case of collaborations in works collective)

Reference to the pages: pp.

Examples: REAL DÍAZ, José J. “El sevillano Rodrigo de Bastidas. Algunas rectificaciones en torno a su figura”. *Archivo Hispalense*, 1962, XXXVI, no. 111-112, pp. 63 -102.

9.- Documentary quotations will be made in the following order:

Name or acronyms (without intermediate points) of the Archive, Library or Institution.

Name of the archival fond or collection (and, if applicable, section), signature.

Name / title of document and date (s) thereof

Example:

Archivo de la Diputación Provincial de Sevilla (ADPSE), Hospital de las Cinco Llagas, lib.102. Libro de defunciones de enfermas, 1739-1765.

10.- The works will be evaluated by the Editorial Council and external evaluators, by the system of peer review and double-blind.

11.- Authors who want to publish their articles in Archivo Hispalense will give in free use rights without any harm to all rights to his work recognized by the Intellectual Property Law. They will be given a maximum of three copies to each author and the separate article in PDF format. A two-year embargo is stipulated.
